Michelle Schnitzius reported as a group the volunteers have completed 418 hours of training to date. Five members attended the S290 Fire Marshal class on fire weather behavior in Ukiah this last month. The last two regular drills consisted of wildland fire stations and Howard Forest dispatch question and answers. Little Lake Fire is hosting two classes this coming Saturday. The AM class will be radio etiquette and the second class will be out of county strike team and both classes are open county wide. Saturday April 20th, 2024, Little Lake Fire will be hosting the burn room out at Station 541 on Baechtel Rd. The drill on April 23rd, 2024, will be over the bank on Highway 20 at the top of 7 mile hill. ICS 300 class is offered on May 6th, 7th and 8th in Santa Rosa. USAR training is

Tony Madrigal added that having a retainer for an engineer company for larger projects is essential. Tony Madrigal added Fire Marshal/Division Chief

FIREFIGHTERS' ASSOC. REPORT: Association President Aaron Branscomb was not in

CHIEF'S REPORT: Deputy Chief John Thomen was not in attendance. Michelle Schnitzius

reported there were 71 calls in March and in April alone so far as of the 9th of April there are 29 calls. The firefighters have been extremely busy. Tony Madrigal reported there were 2 structure fires and a major accident as part of the calls. Tony Madrigal added that it is difficult for medical calls when there is no signage for addresses. Time is of the essence and imperative addresses are posted. Tony Madrigal also added Deputy Chief John Thomen is working hard and has dedicated many

hours to Engine 5469 getting the engine ready for service.
